An Act of the Legislative Assembly of the Cook Islands to appropriate certain sums of money out of the Cook Islands Government Account to the services of the year ending with the thirty-first day of December, 1970, to appropriate the supplies granted in this year by amending the Appropriation Act 1970

(24 December 1970)

MOST GRACIOUS SOVEREIGN, - We, Your Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Cook Islands, towards making good the supply which we have cheerfully granted to Your Majesty in this year, have resolved to grant unto Your Majesty the sums hereinafter mentioned and do therefore most humbly beseech Your Majesty that it may be enacted: And be it enacted by the Legislative Assembly of the Cook Islands in Session assembled, and by the authority of the same as follows:

1. Short Title - This Act may be cited as the Appropriation Amendment Act 1970 and shall be read together with and deemed part of the Appropriation Act 1970 (hereinafter referred to as the principal Act).
2. Grant and Appropriation of \$4,515,233 out of the Cook Islands Government Account - Section 2 subsection (1) of the principal Act is hereby amended by omitting the amount \$4,474,935 and substituting the amount of \$4,515,233.
3. Schedule - The principal Act is hereby further amended by omitting the Schedule and substituting the following Schedule:
