Chapter 22

Beverages, spirits and vinegar

Order

- 1 **Title**
This order is the Customs Tariff Amendment (No.3) Order 2014.
- 2 **Commencement**
This order is deemed to have come into force on 1 July 2014.
- 3 **Principal Act amended**
This order amends Schedule 1 of the Customs Tariff Act 2012 (**the Tariff**).
- 4 **Part 1 of the Tariff amended (Chapter 22)**
The Tariff is amended by deleting chapter 22 and substituting the chapter in the attached Schedule.

5 Part 2 of the Tariff amended (Concessions)

Part 2 (Concessions) of the Tariff is amended by inserting the following concession item after the item relating to reference number 89:

Reference Number	Description	Normal Tariff
90	Goods imported for use in the manufacture of excisable goods in a manufacturing area licensed under the Customs Revenue and Border Protection Act 2012	Free

Explanatory notes—

This concession applies to goods that are to be used in the manufacture of goods subject to excise duty as specified in:

- (i) Part 1, Chapter 99 of the Tariff; and
- (ii) By Order in Executive Council.

This concession only applies if the importer of the goods is the licensee of a manufacturing area licensed under section 15 of the Customs Revenue and Border Protection Act 2012. The Comptroller may require the importer to account for goods that are subject to this concession at any time and by any means. Failure to account for the goods to the satisfaction of the Comptroller will result in duty being re-assessed on the imported goods.

**Schedule 1
The Tariff**

Chapter 22

Beverages, spirits and vinegar

NOTES:

1. This Chapter does not cover:
 - a) Products of this Chapter (other than those of heading 22.09) prepared for culinary purposes and thereby rendered unsuitable for consumption as beverages (generally heading 21.03);
 - b) Sea water (heading 25.01);
 - c) Distilled or conductivity water or water of similar purity (heading 28.53);
 - d) Acetic acid of a concentration exceeding 10 % by weight of acetic acid (heading 29.15);
 - e) Medicaments of heading 30.03 or 30.04; or
 - f) Perfumery or toilet preparations (Chapter 33).
2. For the purposes of this Chapter and of Chapters 20 and 21, the alcoholic strength by volume shall be determined at a temperature of 20 °C.
3. For the purposes of heading 22.02, the term non-alcoholic beverages means beverages of an alcoholic strength by volume not exceeding 0.5 % vol. Alcoholic beverages are classified in headings 22.03 to 22.06 or heading 22.08 as appropriate.

SUBHEADING NOTE:

1. For the purposes of subheading 2204.10, the expression sparkling wine means wine which, when kept at a temperature of 20 °C in closed containers, has an excess pressure of not less than 3 bars.
