#### **AN ACT**

TO APPROPRIATE A SUM NOT EXCEEDING SIX MILLION, FOUR HUNDRED AND EIGHTY FOUR THOUSAND AND EIGHT HUNDRED DOLLARS TO THE SERVICE OF PARLIAMENT FOR 1999

ENACTED by the Parliament of the Fiji Islands-

Short title

1. This Act may be cited as the 1999 Appropriation (Parliament) Act 1998.

Appropriation of \$6,484,800

- 2.—(1) There may be issued from the Consolidated Fund and applied to the service of Parliament for the year ending 31st December 1999 a sum not exceeding six million four hundred and eighty four thousand and eight hundred dollars.
- (2) The sum mentioned in subsection (1) is appropriated for the purposes specified in the Schedule.
