CONSTITUTION OF THE REPUBLIC OF FIJI
*(Section 92(3))***Ministerial Assignment**

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to myself in my capacity as the Prime Minister and Minister for Foreign Affairs, Climate Change, Environment, Civil Service, Information, Public Enterprises and Veteran Affairs with effect from 24 December 2022, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 1 of 2023;

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to myself in my capacity as the Prime Minister and Minister for Foreign Affairs, Climate Change, Environment, Civil Service, Information, Public Enterprises and Veteran Affairs with effect from 1 August 2023, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 66 of 2023;

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to myself in my capacity as the Prime Minister and Minister for Foreign Affairs, Environment and Climate Change, Civil Service and Public Enterprises, Information, Immigration, and Policing, with effect from 1 December 2024, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 99 of 2024;

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to myself in my capacity as the Prime Minister and Minister for Foreign Affairs, Civil Service and Public Enterprises, and Information, with effect from 10 January 2025, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 3 of 2025;

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to myself in my capacity as the Prime Minister and Minister for Foreign Affairs, Civil Service and Public Enterprises, with effect from 5 August 2025, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 46 of 2025;

NOW THEREFORE, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I hereby revoke with effect from 3 November 2025, all assignments and responsibilities under Legal Notice No. 46 of 2025, and with effect from the same day assign to myself in my capacity as the Prime Minister and Minister for Foreign Affairs and External Trade, Civil Service and Public Enterprises, the responsibility for the conduct of the following Government businesses, divisions and written laws (subject to the provisions of any other written law)—
