CONSTITUTION OF THE REPUBLIC OF FIJI
(Section 92(3))

Ministerial Assignment

To: Mr Tomasi Niuvotu Tunabuna
Minister for Agriculture, Waterways, and Sugar Industry

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to you in your capacity as the Minister for Agriculture and Waterways with effect from 5 August 2025, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 47 of 2025;

NOW THEREFORE, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I hereby revoke with effect from 19 January 2026, all assignments and responsibilities under Legal Notice No. 47 of 2025, and with effect from the same day assign to you in your capacity as the Minister for Agriculture, Waterways, and Sugar Industry, the responsibility for the conduct of the following Government businesses, divisions and written laws (subject to the provisions of any other written law)—
