## **Ministerial Assignment**

To: Ms Premila Devi Kumar Minister for Education, Heritage and Arts, and Local Government WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to you in your capacity as the Minister for Industry, Trade, Tourism, Local Government, Housing and Community Development with effect from 22 November 2018, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 99 of 2018;

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to you in your capacity as the Minister for Local Government, Housing and Community Development with effect from 17 April 2020, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 40 of 2020;
