DIPLOMATIC MISSIONS AND INTERNATIONAL ORGANISATIONS ACT 2016 (ACT No. 7 of 2016)

Diplomatic Missions and International Organisations (Statutory Declaration) Regulations 2016

In exercise of the powers conferred upon me under section 11 of the Diplomatic Missions and International Organisations Act 2016, I hereby make these Regulations—

Short title and commencement

- 1.—(1) These Regulations may be cited as the Diplomatic Missions and International Organisations (Statutory Declaration) Regulations 2016.
 - (2) These Regulations come into force on the date the Act comes into force.

Interpretation

- 2.—(1) For the purposes of these Regulations "Act" means the Diplomatic Missions and International Organisations Act 2016.
- (2) In these Regulations, words and phrases have the same meaning as under the Act, unless the context otherwise requires.

Statutory declaration

- 3. For the purposes of making an application under section 5 of the Act, a statutory declaration must be—
 - (a) made in the form prescribed in the Schedule to these Regulations;
 - (b) made before a person listed under section 3 of the Statutory Declaration Act (Cap. 43); and
 - (c) accompanied by a copy of the passport of each individual listed in the statutory declaration intending to enter, reside or work in Fiji.
