FINANCIAL MANAGEMENT ACT 2004

Financial Management (Responsible Authority) Regulations 2019

IN exercise of the powers conferred on me by section 81 of the Financial Management Act 2004, I hereby make these Regulations—

Short title and commencement

- 1.—(1) These Regulations may be cited as the Financial Management (Responsible Authority) Regulations 2019.
 - (2) These Regulations come into force on 1 August 2019.

Responsible authority

- 2. For the purposes of the definition of "responsible authority" in section 2(1) of the Financial Management Act 2004, "person or persons" is—
 - (a) for entities specified in column 2 of the table in the Schedule, the person or persons specified in column 3 of the table in the Schedule; or
 - (b) for any other State entity—
 - (i) that is a department, the permanent secretary for the department;
 - (ii) that is not a department—
 - (A) the board or other governing body of the entity; or
 - (B) if the entity does not have a board or other governing body, the chief executive officer of the entity; or
 - (iii) if subparagraphs (i) and (ii) do not apply in relation to a State entity, the person designated as or performing the functions of the head of the entity, however that designation is expressed.
