## INTERPRETATION ACT (CAP. 7)

## **Rectification of Errors Order 2016**

In exercise of the powers conferred upon me by section 65 of the Interpretation Act (Cap. 7) and with the approval of Cabinet, I hereby make this Order—

Short title and commencement

1. This Order may be cited as the Rectification of Errors Order 2016.

Census Order 2017 (Legal Notice No. 62 of 2016)

2. The printing error in the Census Order 2017 is rectified in order 1(1) by deleting "2017" and substituting "2016".

Commerce (Price Control) (Foodstuffs) Order 2015 (Legal Notice No. 118 of 2015)

3. The printing error in the Commerce (Price Control) (Foodstuffs) Order 2015 is rectified in order 10 by deleting "Commerce (Price Control) (Foodstuffs) (Amendment) (No. 4) Order 2011" and substituting "Counter-Inflation (Price Control) (Foodstuffs) (No. 7) Order 2009".

Criminal Procedure Decree 2009 (Decree No. 43 of 2009)

- 4. The printing error in the Criminal Procedure Decree 2009 is rectified in section 2 by deleting "official notification to a person that the person is accused of committing an offence and that the person is required to appear in the designated court to answer the charge:" and substituting ", unless the context otherwise requires—
  - "charge" means an official notification to a person that the person is accused of committing an offence and that the person is required to appear in the designated court to answer the charge;".

- (k) in section 178(a), deleting "4(1)" and substituting "5(1)";
- (l) in section 185 by—
  - (i) in paragraph (b), deleting "by the Governor of the Reserve Bank of Fiji" and substituting "in accordance with section 136 of the Constitution"; and
  - (ii) deleting paragraph (c);
- (m) in section 192, deleting paragraph (ao) and substituting the following—
  "(ao) in section 55—
  - (i) in subsection (2)(j), inserting "provides" before "that"; and
  - (ii) in subsection (3), deleting "50 penalty points" and substituting "\$5,000";";
- (n) in section 196(b), deleting "section 5" and substituting "section 11(5)";
- (o) in section 201(h), deleting "section 34(2)(d)" and substituting "section 34(2)(g)"; and
- (p) in section 218(b)(i), deleting "section 18(1)(c)(c)" and substituting "section 18(1)(c)".
