TERTIARY SCHOLARSHIPS AND LOANS SERVICE ACT 2014

Tertiary Scholarships Schemes (Amendment) Regulations 2025

IN exercise of the powers conferred on me by section 25(1) of the Tertiary Scholarships and Loans Service Act 2014 and on the recommendation of the Tertiary Scholarships and Loans Service, I hereby make these Regulations—

Short title and commencement

- 1.—(1) These Regulations may be cited as the Tertiary Scholarships Schemes (Amendment) Regulations 2025.
- (2) These Regulations are deemed to have come into force on 1 August 2025.
- (3) In these Regulations, the Tertiary Scholarships Schemes Regulations 2022 is referred to as the “Principal Regulations”.

IN exercise of the powers conferred on me by section 39 of the Fijian Competition and Consumer Commission Act 2010 and on the recommendation of the Fijian Competition and Consumer Commission, I hereby make this Order—

Short title and commencement

1.—(1) This Order may be cited as the Fijian Competition and Consumer Commission (Control of Prices for Sugar Cane Cartage Lorry Services from Rakiraki to Rarawai) Order 2025.

(2) This Order comes is deemed to have come into force on 16 June 2025.
