KING'S REGULATION

TO PROVIDE FOR NATIVE ADMINISTRATION IN THE BRITISH SOLOMON ISLANDS PROTECTORATE.

Made by His Britannic Majesty's High Commissioner for the Western Pacific under the provisions of the Pacific Order in Council 1893.

In the name of His Majesty, GEORGE THE FIFTH, by the Grace of God of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas King, Defender of the Faith, Emperor of India.

[25th November, 1922.]

1. This Regulation may be referred to as the Native Administra- SHORT TITLE. tion (Solomons) Regulation 1922 and shall have force and take effect from the date of its publication in the Gazette.

2. In this Regulation—

INTERPRETATION

- "Territory" shall mean the British Solomon Islands Protectorate;
- "Native Officer" shall mean a Headman of a sub-district or a Village Headman or a Village Constable duly appointed in terms of this Regulation.
- 3. The Resident Commissioner for the time being shall have POWER OF and exercise over natives in the territory all political power and RESIDENT authority subject to such instructions as he may from time to time receive from the High Commissioner.

4. For the purpose of native administration the Resident Com- POWER TO missioner may from time to time subject to the approval of the DIVIDE AND High Commissioner divide and sub-divide the territory into such INTO DISTRICTS. Districts and sub-Districts as he may deem advisable.

5. The District Officer in each District shall be responsible for DISTRICT the administration of native affairs therein subject to such instructions as he may from time to time receive from the Resident Com- FOR ADMINISmissioner.

TRATION OF NATIVE AFFAIRS. POWER TO APPOINT HEADMEN. **6.** The Resident Commissioner on the recommendation of the District Officer may appoint a Headman of each sub-District and may dismiss any Headman so appointed for any breach of this Regulation or of any Rule made thereunder or for any other just cause provided that in the case of dismissal for other reason than a breach of this Regulation or any Rule the circumstances shall be reported to the High Commissioner.

7. The District Officer may appoint Village Headmen and Village Constables and may for any breach of this Regulation or Rule made thereunder or for any other just cause suspend any Village Headman or Constable from the exercise of his duties provided that any such suspension shall be reported to the Resident Commissioner and if confirmed by him shall be reckoned as dismissal from the date of suspension.

POWER OF RESIDENT COM-MISSIONER TO CALL OUT NATIVES IN CASE OF DISORDER. 8. The Resident Commissioner may with the concurrence of the High Commissioner call upon Headmen of sub-Districts to supply men for the defence of the territory and for the suppression of disorder and rebellion within its limits and may call upon such Headmen personally to render such service.

REMUNERATION OF NATIVE OFFICERS.

9. Native Officers shall receive from Government funds such remuneration as may from time to time be fixed by the Resident Commissioner with the approval of the High Commissioner.

DUTIES OF HEADMEN.

- 10. A Headman of a sub-District shall be responsible within his sub-District for—
 - (1) the general good conduct of the natives under his charge;
 - (2) the immediate notification to the District Officer of any crime or offence or serious attempt at crime, of all deaths or suspicious disappearances and of any epidemic or prevailing disease among the natives of his sub-District;
 - (3) the promulgation of all such public orders or notices as he may receive from the District Officer;
 - (4) the nomination of Village Headmen for appointment by the District Officer;
 - (5) the notification to the District Officer of the arrival in his sub-District of any persons not belonging thereto who desire to reside therein;
 - (6) the prompt supply of men called for under section 8 of this Regulation when ordered to supply the same by the Resident Commissioner through the District Officer;
 - (7) the discharge of such further and other duties as may be from time to time prescribed by Regulation or Rule.

DUTIES OF VILLAGE HEADMEN.

- 11. A Village Headman shall be responsible for—
 - (1) the good order and cleanliness of his village;
 - (2) the immediate notification to the Headman of the sub-District of all crimes offences deaths suspicious disappearances and outbreaks of disease in his village;
 - (3) the discharge of such further and other duties as may be from time to time prescribed by Regulation or Rule.

DUTIES OF VILLAGE CONSTABLE. 12. The duties of a Village Constable shall be to aid the Village Headman in the execution of his duties, in the suppression of crime and the apprehension of offenders and generally in the carrying out of the provisions of this Regulation or of any Rule made thereunder.

NATIVE OFFICERS
TO PROMPTLY
COMPLY WITH
ORDERS OF
RESIDENT COMMISSIONER OR
DISTRICT
OFFICER.

13. All Native Officers shall promptly comply with any order of the Resident Commissioner or District Officer issued in conformity with and in pursuance of this Regulation or any Rule made thereunder.

14. Native Officers are authorised and required to arrest any power of native within their sub-Districts in obedience to any lawful warrant TO ARREST. or whom they may see committing or attempting to commit any crime or offence against any person or property or rioting or defying authority and to hand over such native without delay to the District Officer.

15. Any Native Officer who shall be found guilty of blackmail PENALTY ON extortion intimidation oppression or other abuse of his authority CONVICTION FOR OFFENDES BY shall be liable on conviction to a fine not exceeding £10 or to im- NATIVE OFFICERS prisonment with or without hard labour for a period not exceeding six months.

16. All natives shall comply with all orders of Native Officers NATIVES TO issued in compliance with or in pursuance of this Regulation or COMPLY WITH any Rule made thereunder and with any reasonable order request NATIVE or direction made by a District Officer, and shall when so required OFFICIALS. assist in the promulgation of public orders and regulations and in any measure undertaken by the Government for the general welfare.

17. Any native wilfully obstructing the execution of any lawful PENALTY FOR order or bringing Government authority into contempt shall be COVERNMENT guilty of an offence and shall be liable upon conviction to AUTHORITY. imprisonment with or without hard labour for a term not exceeding six months or to a fine not exceeding ten pounds and in default of payment to imprisonment with or without hard labour for a term not exceeding three months unless such fine be sooner paid or to both such fine and imprisonment.

18. Any native officer or other native failing or neglecting with- FAILURE OF out reasonable excuse to carry out any of the duties prescribed by NATIVES TO CARRY OUT this Regulation or by any Rule made thereunder shall be deemed DUTIES PREguilty of an offence and shall be liable on conviction to the prescribed penalty or when no special penalty is provided to a fine RULES MADE not exceeding £5 or to imprisonment with or without hard labour THEREUNDER. for a period not exceeding three months.

19. Subject to the approval of the High Commissioner the Resi- RESIDENT COMdent Commissioner may by notice in the Gazette make Rules not MISSIONER MAY MAKE RULES. inconsistent with this Regulation—

(1) prescribing additional duties for Native Officers;

- (2) for the sanitation of Villages and the preservation of public health;
- (3) for the prevention of 'nuisances;
- (4) for the cultivation of foodstuffs and the performance of communal services;
- (5) for the notification of births and deaths;
- (6) generally for the preservation of good order the suppression of evil practices and the improvement of social conditions among natives;

and may prescribe penalties for the breach thereof.
