Public Law No. 7 - 1

AN ACT

To further amend Public Law No. 6-91, as amended by Public Law No. 6-103, by amending sections 2 and 12 for the purpose of appropriating the sum of \$793,956 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1991, as supplemental funding for operating expenses of the legislative branch, the Office of the President, political education on proposed amendments to the Constitution, a meeting of the South Pacific Forum, and for the costs of a special election, and for the purpose of reprogramming certain funds previously appropriated for the legislative branch; by amending section 12 for the purpose of making a technical correction to the operating subsidy for the Federated States of Micronesia Development Bank for the fiscal year ending September 30, 1991; by amending section 15 for the purpose of modifying the use of energy funds appropriated therein; by amending section 18 for the purpose of specifying the allottee of certain supplemental funding; and for other purposes.

expended to support the activities of the State Political Education Coordinating Committees; PROVIDED, however, that if such funds are used to compensate members or staff of such committees who are not government employees, then such compensation may not exceed \$25 per day and, when traveling away from their residence on the business of the committees, such compensation is permitted to be in addition to any per diem, stipend, or travel expense allowance; PROVIDED FURTHER, that if such funds are used to compensate members or staff of such committees who are government employees for time spent on the business of the committees in excess of the standard number of hours per week for which they are compensated by a government, then such compensation shall not exceed the hourly rate at which they would be compensated as overtime for their government employment and, when traveling away from their residence on the business of the committees, such compensation shall not be permitted to be in addition to any per diem, stipend, or travel expense allowance. Expenses permitted under this paragraph may include goods or services received prior to the date this paragraph becomes law. 19	to read as follows:
20	"Section 15. Energy budget. The sum of \$228,000, or so
21	much thereof as may be necessary, is hereby appropriated
22	from the General Fund of the Federated States of Micronesia
23	for the fiscal year ending September 30, 1991, for the
24	operation of the generator at the National Capital and for
25	fuel expenses of the executive branch motor pool. The

1	funds appropriated under this section shall be deemed to
2	come from the funds available under section 214(b) of the
3	Compact of Free Association."
4	Section 4. Section 18 of Public Law No. 6-91 is hereby amended
5	to read as follows:
6	"Section 18. Allotment and management of funds and lapse
7	date. All funds appropriated by this act shall be allotted,
8	managed, administered, and accounted for in accordance with
9	applicable law, including, but not limited to, the
10	Financial Management Act of 1979, as amended; PROVIDED,
11	however, that the allottees for funds appropriated under
12	paragraph (m) of subsection (2) of section 12 of this act
13	shall be the Governors of the respective States and that
14	those funds shall not be disbursed from the General Fund to
15	the allottee unless the President certifies that the State
16	involved has entered into a joint law enforcement agreement
17	for the period of October 1, 1990 to September 30, 1991,
18	with the National Government pursuant to chapter 12 of
19	title 12 of the Code of the Federated States of Micronesia;
20	PROVIDED FURTHER, that the allottee of the funds appro-
21	priated under paragraph (h) of subsection (1) of section 12
22	of this act shall be the President, or his designee or
23	designees. Each allottee shall be responsible for ensuring
24	that these funds, or so much thereof as may be necessary,
25	are used solely for the purposes specified in this act, and

1	that no obligations are incurred in excess of the sum appro-
2	priated. The authority of the allottees to obligate funds
3	appropriated by this act shall lapse as of September 30,
4	1991; PROVIDED, however, that the authority of the allottee
5	or his designees to obligate funds appropriated by
6	subsection (7) of section 2 of this act shall lapse as of
7	May 9, 1991; PROVIDED FURTHER, that the funds appropriated
8	under subsection (8) of section 2 of this act shall not be
9	allotted before May 10, 1991 and the authority of the
10	allottee or his designees to obligate the funds under such
11	subsection shall lapse as of May 9, 1992; PROVIDED FURTHER,
12	that the authority of the allottees to obligate funds
13	appropriated by sections 6, 9, 10, 12(2)(p) and 13 shall
14	not lapse."
15	Section 5. This act shall become law upon approval by the
16	President of the Federated States of Micronesia or upon its becoming
17	law without such approval.
