CONGRESSIONAL BILL NO. 7-360
Public Law No. 7 - 85

AN ACT

To further amend Public Law No. 6-49, as amended, Chuuk State public projects, by further amending section 9, as amended by Public Laws Nos. 6-55 and 7-69, to clarify the intended use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 9 of Public Law No. 6-49, as amended by
2 Public Laws Nos. 6-55 and 7-69, is hereby further amended to read as
3 follows:

4 "Section 9. Uman Fonuweisom public projects. The sum of
5 \$130,000, or so much thereof as may be necessary, is hereby
6 appropriated from the General Fund of the Federated States
7 of Micronesia for the fiscal year ending September 30, 1990,
8 for the purpose of funding certain public projects in Uman,
9 Fonuweisom, Southern Namoneas, Chuuk State. The sum appro-
10 priated by this section shall be apportioned as follows:


