PRESIDENTIAL COMM. NO. 8-144
FSM CONGRESS

To further amend Public Law No. 3-56, as amended, by further amending section 1, as amended by Public Laws Nos. 3-71, 4-8, 4-49, 4-80, 5-133 and 6-68, to reallocate funds for certain Chuuk State public projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-56, as amended by
2 Public Laws Nos. 3-71, 4-8, 4-49, 4-80, 5-133 and 6-68, is hereby
3 further amended to read as follows:

4 "Section 1. The sum of \$789,700, or so much thereof as
5 may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1985, for the purpose of funding
8 public projects in the State of Truk. The sum appropriated
9 herein shall be apportioned as follows:

 - 12 supplies and equipment..... \$ 20,000
 - 13 (b) Purchase of Truk
 - 14 dispensaries' medical supplies and equipment.... 10,000


