

**PRESIDENTIAL COMM. NO. 8-237**  
**FSM CONGRESS**

**Public Law No. 8-69**

AN ACT

To further amend Public Law No. 6-88, as amended by Public Laws Nos. 6-93 and 6-95, by further amending sections 1 and 3, as amended by Public Law No. 6-95, by further amending section 2, as amended by Public Law No. 6-93, and by amending section 4 for the purpose of modifying the use of funds previously appropriated therein for the Mortlocks in Chuuk State, by amending section 5 for the purpose of changing the allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 6-88, as amended by  
2 Public Law No. 6-95, is hereby further amended to read as follows:

3 "Section 1. The sum of \$92,905.72, or so much thereof as  
4 may be necessary, is hereby appropriated from the General  
5 Fund of the Federated States of Micronesia for the fiscal  
6 year ending September 30, 1990, for the purpose of funding  
7 public projects in the Upper Mortlocks area of the Mortlocks  
8 Islands of Chuuk State. The sum appropriated by this section  
9 shall be apportioned as follows:

24 Section 5. Section 5 of Public Law No. 6-88 is hereby amended to  
 25 read as follows:

1 "Section 5. All funds appropriated by this act shall be  
2 allotted, managed, administered, and accounted for in  
3 accordance with applicable law, including, but not limited  
4 to, the Financial Management Act of 1979. The allottee of  
5 the funds appropriated by this act shall be the Lower Mortlocks  
6 Development Authority. The allottee shall be responsible for  
7 ensuring that these funds, or so much thereof as may be  
8 necessary, are used solely for the purposes specified in this  
9 act, and that no obligations are incurred in excess of the sum  
10 appropriated. The authority of the allottee to obligate funds  
11 appropriated by this act shall not lapse until expended."

12 Section 6. This act shall become law upon approval by the  
13 President of the Federated States of Micronesia or upon its becoming  
14 law without such approval.
