

AN ACT

To further amend Public Law No. 7-24, as amended, Pohnpei public projects, by further amending section 1, as amended by Public Laws Nos. 7-63 and 7-74, to reallocate certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1        Section 1. Section 1 of Public Law No. 7-24, as amended by Public Laws  
2        Nos. 7-63 and 7-74, is hereby further amended to read as follows:  
3                "Section 1. Sokehs, Kolonia, Sapwuahfik, Nukuoro, and  
4                Kapingamarangi public projects. The sum of \$925,000, or so much  
5                thereof as may be necessary, is hereby appropriated from the  
6                General Fund of the Federated States of Micronesia for the fiscal  
7                year ending September 30, 1992, for the purpose of funding public  
8                projects in Sokehs, Kolonia, Sapwuahfik, Nukuoro, and  
9                Kapingamarangi, Pohnpei State. The sum appropriated under this  
10               section shall be apportioned as follows:
