AN ACT

To further amend Public Law No. 8-113, as amended by Public Law No. 8-129, by further amending section 3, as amended by Public Law No. 8-129, for the purpose of modifying and reallocating funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 8-113, as amended by
2	Public Law No. 8-129, is hereby further amended to read as follows:
3	"Section 3. The sum of \$300,000, or so much thereof as
4	may be necessary, is hereby appropriated from the General
5	Fund of the Federated States of Micronesia for the fiscal
6	year ending September 30, 1995, for the purpose of
7	providing funding for social and economic development
8	projects in Yap State. The funds appropriated by this
9	section shall be apportioned and allocated as follows:
10	(1) Yap State youth project \$ 70,000
11	(2) Other public projects
12	(a) Repair and renovation of Falalop Ulithi
13	Dispensary
14	(b) Rang/Gilfith basketball court 15,000
15	(c) Gilman Elementary School 30,000
16	(d) Tomil Elementary School 95,000
