

AN ACT

To further amend Public Law No. 4-17, as amended by Public Laws Nos. 4-47, 4-60, 7-62, 8-31 and 8-55, Kosrae State public projects, by further amending section 2, as amended by Public Laws Nos. 4-47, 4-60 and 7-62, to modify the uses of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 4-17, as amended by Public Laws Nos. 4-47, 4-60 and 7-62, is hereby further amended to read as follows:

"Section 2. The sum appropriated under section 1 of this act shall be apportioned as follows:
