

AN ACT

To further amend Public Law No. 7-24, as amended, Pohnpei public projects, by further amending section 1, as amended by Public Laws Nos. 7-63, 7-74 and 8-106, to reallocate certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 7-24, as amended by Public Laws Nos. 7-63, 7-74 and 8-106, is hereby further amended to read as follows:

"Section 1. Sokehs, Kolonia, Sapwuahfik, Nukuoro, and Kapingamarangi public projects. The sum of \$925,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1992, for the purpose of funding public projects in Sokehs, Kolonia, Sapwuahfik, Nukuoro, and Kapingamarangi, Pohnpei State. The sum appropriated under this section shall be apportioned as follows:
