PUBLIC LAW NO. 9-067

AN ACT

To appropriate the sum of \$1,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of providing assistance for educational purposes other than salaries, travel, training or vehicles, to non-public and public schools throughout the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. The sum of \$500,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of providing assistance restricted to uses other than salaries, travel, training or vehicles to non-public and public schools in the State of Chuuk. The funds appropriated under this section shall be apportioned as follows:

(2)	Mizpah High School	75,000	
(3)	Berea Christian School	75,000	
(4)	Pentecostal Lighthouse High School Academy	75,000	
(5)	SDA School	50,000

Section 2. The sum of \$300,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of providing assistance restricted to uses other than salaries, travel, or vehicles, to non-public and public schools in the State of Pohnpei. The funds appropriated under this section shall be apportioned as follows:

(1) Pohnpei Catholic School......\$ 100,000

(2) Ohwa Christian High School	100,000

- Section 3. The sum of \$200,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of providing assistance restricted to uses other than salaries, travel, or vehicles, to public and non-public schools in the State of Yap. The funds appropriated under this section shall be apportioned as follows:
 - (1) Xavier High School.....\$ 25,000
 - (2) SDA School..... 120,000
 - (3) St. Mary's School..... 55,000

Section 4. The sum of \$100,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of providing assistance restricted to uses other than salaries, travel, or vehicles, to public and non-public schools in the State of Kosrae. The funds appropriated under this section shall be apportioned as follows:

- (1) Kosrae SDA School.....\$ 15,000

Section 5. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated by section 1 of this act shall be the Secretary of Education of the Federated States of Micronesia or his designee. The allottee of the funds appropriated by sections 2 and 4, of this act shall be the President of the Federated States of Micronesia or the President's designee. The allottee of the funds appropriated by section 3 of this act shall be the Governor of the State of Yap. The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are

incurred in excess of the sum appropriated. The authority of the allottees to obligate funds appropriated by this act shall lapse as of September 30, 1997.

Section 6. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
