AN ACT

To further amend Public Law No. 6-49, as amended, by further amending section 4, as amended by Public Law No. 6-55, for the purpose of changing the allocation of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 4 of Public Law No. 6-49, as amended by Public Law No. 6-55, is hereby further amended to read as follows:

"Section 4. Faichuk public projects. The sum of \$500,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding certain public projects in Faichuk, Chuuk State. The sum appropriated by this section shall be apportioned as follows:
