AN ACT

To further amend Public Law No. 8-93, as amended by Public Laws Nos. 8-98, 8-123, 8-137 and 9-020, by further amending section 1, as amended by Public Law No. 8-98, for the purpose of specifying the apportionment of the funds appropriated, and by amending section 2, as amended by Public Laws Nos. 8-98, 8-123, 8-137 and 9-020, for the purpose of designating the allottees of said funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 8-93, as amended by Public Law No. 8-98, is hereby amended to read as follows:

"Section 1. The sum of \$1,300,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for school needs throughout the Federated States of Micronesia. The funds appropriated under this act shall be apportioned as follows:

Section 2. Section 2 of Public Law No. 8-93, as amended by Public Laws Nos. 8-98, 8-123, 8-137 and 9-20, is hereby amended to read as follows: "Section 2. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allotee of the funds appropriated under subsection (1)(a)(i), (1)(a)(ii) and (1)(a)(iii) of section 1 of this act shall be the Tolensom Authority. The allottee of the funds appropriated under subsection (1)(b) of section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under subsection (1)(c) of section 1 of this act shall be the Southern Namoneas Authority. The allottee of the funds appropriated under subsection (1)(d)(i) and (1)(d)(ii) of section 1 of this act shall be the Pattiw Development Authority. The allottee of the funds appropriated under subsection (1)(e)(xiii) of section 1 of this act shall be the Lower Mortlocks Development Authority. The allottee of the funds appropriated under subsection (4) of section 1 of this act shall be the Governor of the State of Yap or his designee. The

allottee of all other funds appropriated by this act shall be the

President of the Federated States of Micronesia or the President's

designee. The allottees shall be responsible for ensuring that these
