

AN ACT

To further amend Public Law No. 3-59, as amended by Public Laws Nos. 6-27, 8-15 and 9-064, by further amending section 1, as amended by Public Law No. 9-064, for the purpose of changing the allocation of funds therein, and by further amending section 2, as amended by Public Laws Nos. 6-27 and 8-15, for the purpose of changing the allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 3-59, as amended by Public Law No. 9-064, is hereby amended to read as follows:

"Section 1. The sum of \$287,800, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, for the purpose of funding public projects in the Faichuk area of the State of Chuuk. The sum appropriated by this section shall be apportioned as follows:

Section 2. Section 2 of Public Law No. 3-59, as amended by Public Laws No. 6-27 and 8-15, is hereby amended to read as follows:

"Section 2. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to the Financial Management Act of 1979. The allottee shall be the Mayor of Tolensom who shall be

responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated; PROVIDED, however, that funds appropriated by this act shall be disbursed solely by the Finance Office of the Federated States of Micronesia in Chuuk State. The authority of the allottee to obligate funds appropriated by this act shall continue until the funds appropriated herein are expended."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
