

AN ACT

To further amend Public Law No. 9-052, as amended, by further amending section 2, as amended by Public Laws Nos. 9-094, 9-117, 9-160, 10-69, and 10-106; and to amend Public Law No. 10-126, by amending section 3; to reprogram funds from the latter law to the former law and to modify the uses of funds appropriated for Kolonia Town; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 9-052, as amended by Public Laws Nos. 9-094, 9-117, 9-160, 10-69, and 10-106, is hereby further amended to read as follows:

"Section 2. The sum of \$2,200,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, and the sum of \$600,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding infrastructure needs, transportation systems, and other economic, social and public projects in Pohnpei State. The funds appropriated under this section shall be apportioned as follows:

- (1) Election District No. 1
 - (a) Kipar, Lewetik and Tomara, bridge construction, road pavement or maintenance \$ 200,000
 - (b) Sokehs public projects
 - (i) Sokehs Pah Road pavement... 100,000
 - (ii) Sokehs Island circumferential road..... 100,000
 - (iii) Nanmal/Kipar/Tomara/Lewetik road pavement supplement..... \$ 160,000
 - (iv) Administrative costs for implementation..... 41,000
 - (v) Sokehs basketball court project supplement..... 25,000

Section 2. Section 3 of Public Law No. 10-126 is hereby amended to read as follows:

"Section 3. The sum of \$50,750, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding health, education, infrastructure and other public projects and programs in the State of Pohnpei. The funds appropriated under subsection (1) of this section shall be deemed to come from the communication operations and maintenance account, section 215(a)(2) of the Compact of Free Association. The funds appropriated herein shall be apportioned as follows:

(1) Department of Public Safety, Pohnpei State - communication equipment.....	\$	50,750
