

PUBLIC LAW NO. 13-80

AN ACT

To further amend Public Law No. 13-36, as amended, by amending sections 3 and 5 thereof to change the use and allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 13-36, as amended by
2 Public Laws Nos. 13-49 and 13-66, is hereby further amended to
3 read as follows:

4 "Section 3. The sum of \$800,000, or so much thereof as
5 may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2004, to provide
8 funding for social and economic development projects in
9 the State of Pohnpei. The funds appropriated under this
10 section shall be apportioned as follows:

11 (1) Pohnpei Chamber of Commerce - Travel of
12 Businessmen to United States\$ 20,000

18 Section 2. Section 5 of Public Law No. 13-36, as amended by
19 Public Laws Nos. 13-49 and 13-66, is hereby further amended to
20 read as follows:

21 "Section 5. Allotment and management of funds and lapse
22 date.

23 (1) All funds appropriated by this act shall be allotted, mana
24 allottee of the funds appropriated under sections 1, 2
25 and 3 of this act shall be the President of the

1 Federated States of Micronesia or his designee, except
2 that the allottee of the funds appropriated under
3 subsections 1(1), 1(3) and 1(4) of this act shall be the
4 Governor of the State of Kosrae; the allottee of the
5 funds appropriated under sections 2(3) and 2(4) of this
6 act shall be the Governor of the State of Yap; the
7 allottee of the funds appropriated under sections 2(5),
8 2(6) and 2(7) shall be the Speaker of Congress; the
9 allottee of the funds appropriated under subsection
10 3(2)(a)(i) shall be the mayor of Kolonia Town; the
11 allottee of the funds appropriated under subsections
12 3(2)(a)(ii), 3(2)(a)(iv) and 3(2)(a)(v) shall be the
13 Sokehs magistrate; the allottee of the funds
14 appropriated under subsection 3(2)(a)(iii) shall be the
15 mayor of Nukuoro; and the allottee of funds appropriated
16 under subsections 3(2)(c)(vi) and 3(2)(c)(vii) shall be
17 the Pohnpei Transportation Authority. The allottee of
18 the funds appropriated under section 4 of this act shall
19 be the Chuuk State Commission on Improvement Projects,
20 except that the funds appropriated under section 4(1)(c)
21 of this act shall be allotted to the President of the
22 Federated States of Micronesia.

23 (2) The allottees of the funds appropriated herein
24 shall be responsible for ensuring that these funds, or
25 so much thereof as may be necessary, are used solely for

1 the purpose specified herein, and shall report back to
2 the Congress on the status of these funds no later than
3 September 30, 2005. The authority of the allottees to
4 obligate such funds shall not lapse until fully
5 expended."

6 Section 3. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its
8 becoming law without such approval.
