

AN ACT

To further amend Public Law No. 13-36, as amended, by amending section 3 thereof to change the use of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 13-36, as amended by Public Laws
2 Nos. 13-49, 13-66 and 13-80, is hereby further amended to read as follows:

3 "Section 3. The sum of \$800,000, or so much thereof as may be
4 necessary, is hereby appropriated from the General Fund of the
5 Federated States of Micronesia for the fiscal year ending September
6 30, 2004, to provide funding for social and economic development
7 projects in the State of Pohnpei. The funds appropriated under
8 this section shall be apportioned as follows:
