

AN ACT

To amend Public Law No. 13-84, by amending section 1 thereof to change the use of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 13-84 is hereby  
2 amended to read as follows:

3 "Section 1. The sum of \$240,000, or so much  
4 thereof as may be necessary, is hereby appropriated  
5 from the fund entitled 'Public Projects for Chuuk  
6 Election District No. 5' within the General Fund,  
7 to provide funding for public projects in Chuuk  
8 Election District No. 5. The funds appropriated  
9 under this section shall be apportioned as follows:

- 10 (1) Junior high school hot lunch .....\$ 5,000
- 11 (2) Tuition, room and board assistance for  
12 students for the Northwest region of Chuuk  
13 at the College of Micronesia main campus ... 16,100
- 14 (3) Strategy/planning meeting of the  
15 leaders of the Northwest region
  - 16 (a) POL and charter boats ..... 20,000
  - 17 (b) Travel allowance and rental ..... 5,000
  - 18 (c) Supplies and materials ..... 1,500
  - 19 (d) Venue rental and refreshments ... 2,900
- 20 (4) Replanting and rehabilitation project for all  
21 thirteen islands in Halls, Weito and Pattiw Islands
