

AN ACT

To further amend section 8 of Public Law No. 16-7, as amended by Public Laws Nos. 16-25, and 16-35, to modify the use of a line item for the Office of Environment and Emergency Management, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 8 of Public Law No. 16-7, as amended by  
2 Public Law Nos. 16-25 and 16-35, is hereby further amended to  
3 read as follows:

4 "Section 8. Grants, Subsidies and Contributions. The  
5 sum of \$5,640,092 or so much thereof as may be  
6 necessary, is hereby appropriated from the General Fund  
7 of the Federated States of Micronesia for the fiscal  
8 year ending September 30, 2010 for the following grants,  
9 subsidies and contributions during fiscal year 2010. Of  
10 the total amount of funds appropriated herein, -0- shall  
11 be deemed to come from funds available under the amended  
12 Compact from education sector; and \$-0- shall be deemed  
13 to come from funds available under Supplemental  
14 Education Grant. The sum appropriated by this section  
15 shall be apportioned as follows:
