

AN ACT

To further amend Public Law No. 18-05, as amended by Public Laws Nos. 18-07 and 18-14, by amending section 4 therein, for the purpose of changing the use of funds previously appropriated to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 4 of Public Law No. 18-05, as amended  
2 by Public Law No. 18-07, is hereby further amended to read as  
3 follows:

4           "Section 4. Of the sum of \$2,500,000 appropriated by  
5 this act, \$700,000 is apportioned for Pohnpei State for  
6 public projects and social programs.
