

AN ACT

To further amend Public Law No. 17-36, as amended by Public Laws Nos. 17-48, 17-78, 17-87, 18-36 and 18-60, by amending sections 4 and 6 thereof, for the purpose of changing the use and allottee of certain funds previously appropriated therein for the purpose of funding public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 17-36, as
2 amended by Public Law No. 17-48, 17-78 and 17-87, 18-36 and
3 18-60, is hereby further amended to read as follows:

4 "Section 4. Of the sum of \$2,100,000
5 appropriated by this act, \$600,000 is
6 apportioned for Pohnpei State for public
7 projects and social programs.

3 Section 2. Section 6 of Public Law No. 17-36, as amended
 4 by Public Laws Nos. 17-48, 17-78, 17-87, 18-36 and 18-60, is
 5 hereby further amended to read as follows:

6 "Section 6. Allotment and management of funds and
 7 lapse date. All funds appropriated by this act shall
 8 be allotted, managed, administered and accounted for
 9 in accordance with applicable laws, including, but not
 10 limited to, the Financial Management Act of 1979. The
 11 allottee shall be responsible for ensuring that these
 12 funds, or so much thereof as may be necessary, are
 13 used solely for the purpose specified in this act, and
 14 that no obligations are incurred in excess of the sum
 15 appropriated. The allottee of the funds appropriated
 16 under Section 2 of this act shall be the Governor of
 17 Yap State. The allottee of funds appropriated under
 18 sections 3 and 4 of this act shall be the President of
 19 the Federated States of Micronesia or his designee,
 20 EXCEPT THAT the allottee of funds appropriated under
 21 subsection 4(1)(b), 4(3)(a) and (b) of section 4 of
 22 this act shall be the Pohnpei Transportation
 23 Authority. The allottee of funds appropriated under
 24 subsection 4(2)(j) of section 4 shall be the Chief
 25 Magistrate of Sokehs Municipal Government. The

1 allottee of funds appropriated under subsections 5(1)
2 and 5(3) of section 5 of this act shall be the
3 Governor of Chuuk State or his designee. The allottee
4 of funds appropriated under subsection 5(2) of section
5 5 of this act shall be the Mortlock Islands
6 Development Authority; the allottee of funds
7 appropriated under subsection 5(4) of section 5 of
8 this act shall be the Southern Namoneas Development
9 Authority. The allottee of funds appropriated under
10 subsection 5(5) of section 5 of this act shall be the
11 Faichuk Development Authority. The allottee of funds
12 appropriated under subsection 5(6) of section 5 of
13 this act shall be the Northwest Development Authority
14 (NWDA), PROVIDED THAT the allottee of the funds
15 appropriated under subsection 5(6)(f) shall be the
16 President of COM-FSM. The authority of the allottee
17 to obligate funds appropriated by this act shall lapse
18 on September 30, 2014.”
