

AN ACT

To amend section 1 of Public Law No. 1-142 to allow funds to be used for the construction of a municipal building in Moch, State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 1-142 is hereby amended
2 to read as follows:

3 "Section 1. The sum of \$636,300, or so much thereof as may
4 be necessary, is hereby appropriated from the General Fund
5 of the Federated States of Micronesia for the Fiscal Year
6 ending September 30, 1981, for the purpose of funding certain
7 public projects in the State of Truk. The sum appropriated
8 shall be apportioned in the following manner:
