

AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15 and 20-33, by amending sections 4, 5 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs in the states of Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4. Section 4 of Public Law No. 19-124,
2 as amended by Public Laws Nos. 19-133, 19-140, 20-05, 20-15 and
3 20-33, is hereby further amended to read as follows:

4 "Section 4. Of the \$11,300,000 appropriated under this
5 act, \$3,000,000 shall be apportioned for priority
6 infrastructure projects and other programs in the state
7 of Pohnpei.

8 Section 3. Section 6 of Public Law No. 19-124, as amended by
 9 Public Laws Nos. 19-133, 19-140, 20-05, 20-15 and 20-33, is hereby
 10 further amended to read as follows:

11 "Section 6. Allotment and management of funds and lapse
 12 date. All funds appropriated by this act shall be
 13 allotted, managed, administered and accounted for in
 14 accordance with applicable laws, including, but not
 15 limited to, the Financial Management Act of 1979. The
 16 allottee shall be responsible for ensuring that these
 17 funds, or so much thereof as may be necessary, are used
 18 solely for the purpose specified in this act, and that
 19 no obligations are incurred in excess of the sum
 20 appropriated. The allottee of the funds appropriated
 21 under section 2 of this act shall be the Governor of the
 22 State of Yap or his designee. The allottee of the funds
 23 appropriated under sections 3 and 4 of this act shall be
 24 the President of the Federated States of Micronesia or
 25 his designee; PROVIDED THAT, the allottee of funds

1 appropriated under subsections 3(1)(a) and 3(1)(b) of
2 this act shall be the Governor of Kosrae State or his
3 designee, the allottee of funds appropriated under
4 subsections 4(1)(c) through 4(1)(o), 4(2)(f), 4(4)(b),
5 4(4)(d), 4(4)(f), shall be the Pohnpei Transportation
6 Authority (PTA); the allottee of funds appropriated
7 under subsections 4(1)(a), 4(1)(b), 4(2)(c), 4(2)(d),
8 4(2)(e), 4(2)(g), 4(2)(h), 4(2)(i) and 4(2)(j) shall be
9 the Secretary of the Department of Transportation,
10 Communications and Infrastructure or his designee; the
11 allottee of funds appropriated under subsections
12 4(3)(f), 4(3)(i), 4(3)(q) 4(3)(w), 4(3)(x) and 4(3)(aa)
13 of this act shall be the Luhk en Moanlap of Kitti, the
14 allottee of funds appropriated under subsection 4(3)(ad)
15 of this act shall be the Chief Justice of Madolenihmw or
16 his designee, the allottee of funds appropriated under
17 subsection 4(3)(ae) of this act shall be the Chief
18 Justice of Kitti or his designee. The allottee of the
19 funds appropriated under section 5 of this act shall be
20 the Governor of Chuuk State or his designee. The
21 authority of the allottee to obligate funds appropriated
22 by this act shall lapse on September 30, 2019.”

2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
