

AN ACT

To further amend Public Law No. 21-43, as amended by Public Laws Nos. 21-54, 21-71, 21-82 and 21-103, by amending sections 5 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 21-43, as amended by
2 Public Law No. 21-54 and 21-82, is hereby amended to read as
3 follows:

4 "Section 5. Of the \$4,200,000 appropriated
5 under this act, \$1,800,000 shall be apportioned
6 for public projects and social programs for the
7 people of Chuuk State.

16 Section 2. Section 6 of Public Law No. 21-43, as amended by
 17 Public Laws Nos. 21-54 and 21-71, is hereby further amended to
 18 read as follows:

19 "Section 6. Allotment and management of funds and lapse
 20 date. All funds appropriated by this act shall be
 21 allotted, managed, administered and accounted for in
 22 accordance with applicable laws, including, but not
 23 limited to, the Financial Management Act of 1979. The
 24 allottee shall be responsible for ensuring that these
 25 funds, or so much thereof as may be necessary, are used

1 solely for the purpose specified in this act, and that no
2 obligations are incurred in excess of the sum
3 appropriated. The allottee of the funds appropriated
4 under section 2 of this act shall be the Governor of Yap
5 State or his designee; PROVIDED THAT, the allottee of
6 funds appropriated under subsection 2(f) of this act shall
7 be the President of the COM-FSM Institute. The allottee
8 of funds appropriated under sections 3 and 4 of this act
9 shall be the President of the Federated States of
10 Micronesia or his designee; PROVIDED THAT, the allottee of
11 funds appropriated under subsection 3(1) of this act shall
12 be the Governor of Kosrae State or his designee; the
13 allottee of funds appropriated under subsection 3(2) of
14 this act shall be the Mayor of Lelu Town Government or his
15 designee. The allottee of funds appropriated under
16 section 4(1) and 4(3)(1) of this act shall be the Vice
17 President; The allottee of funds appropriated under
18 subsection 4(1)(a) and section 4(2) of this act shall be
19 the Secretary of the Department of Transportation,
20 Communications and Infrastructure or his designee, except
21 that the allottee of funds appropriated under subsections
22 4(2)(e), 4(2)(j), 4(2)(m), 4(4)(j), 4(4)(k), 4(4)(l) and
23 4(4)(m) of this act shall be the Pohnpei Transportation
24 Authority (PTA); the allottee of funds appropriated under
25 subsections 4(2)(l), 4(3)(d) and 4(3)(f) of this act shall

1 be the Secretary of the Department of Education or his
2 designee; the allottee of funds appropriated under
3 subsection 4(2)(h) of this act shall be the President of
4 COM-FSM; the allottee of funds appropriated under
5 subsections 4(3)(a), 4(3)(b), 4(3)(e), 4(3)(h), 4(3)(i)
6 and 4(3)(k) of this act shall be the Meninkeder of
7 Madolenihmw; the allottee of funds appropriated under
8 subsection 4(3)(c) of this act shall be the Chief Justice
9 of Madolenihmw Municipal Government; the allottee of funds
10 appropriated under subsection 4(3)(g) of this act shall be
11 the Luhkenmoanlap of Kitti; the allottee of funds
12 appropriated under subsection 4(3)(j) of this act shall be
13 the Speaker of Isokoneddi of Kitti; the allottee of funds
14 appropriated under subsection 4(3)(m) of this act shall be
15 the Director of Pohnpei Public Safety. The allottee of
16 the funds appropriated under sections 5(1) and 5(6) of
17 this act shall be the Governor of Chuuk State or his
18 designee; the allottee of the funds appropriated under
19 subsection 5(2) of this act shall be the Mortlocks Island
20 Development Authority (MIDA); the allottee of the funds
21 appropriated under subsection 5(4) of this act shall be
22 the Southern Namoneas Development Authority; the allottee
23 of the funds appropriated under subsection 5(5) of this
24 act shall be the Faichuk Development Authority. The
25 allottee of funds appropriated under subsection 5(3) of

1 this act shall be the Mayor of Weno Municpal Government or
2 his designee. The authority of the allottee to obligate
3 funds appropriated by this act shall lapse on September
4 30, 2022.”

5 Section 3. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its
7 becoming law without such approval.
