

AN ACT

To further amend Public Law No. 19-121, as amended by Public Laws Nos. 19-130, 19-142, 19-145, 19-158, 20-09, 20-22, 20-51, 20-59, 20-70, 20-123, 20-162, 20-170, 21-35, 21-66, 21-112 and 21-127, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 19-121, as amended by
2 Public Laws Nos. 19-130, 19-142, 20-09, 20-70 and 21-66, is hereby
3 further amended to read as follows:

4 "Section 3. Of the sum of \$5,450,000 appropriated by this
5 act, \$1,100,000 is apportioned to fund public projects and
6 social programs for the people of the state of Kosrae.

4 Section 2. Section 6 of Public Law No. 19-121, as amended
 5 by Public Laws Nos. 19-130, 19-142, 20-09, 20-70, 20-123, 20-162,
 6 20-170, 21-35, 21-66 and 21-127, is hereby further amended to
 7 read as follows:

8 "Section 6. Allotment and management of funds and
 9 lapse date. All funds appropriated by this act shall
 10 be allotted, managed, administered and accounted for in
 11 accordance with applicable laws, including, but not
 12 limited to, the Financial Management Act of 1979. The
 13 allottee shall be responsible for ensuring that these
 14 funds, or so much thereof as may be necessary, are used
 15 solely for the purpose specified in this act, and that
 16 no obligations are incurred in excess of the sum
 17 appropriated. The allottee of the funds appropriated
 18 under section 2 of this act shall be the Governor of
 19 Yap State; PROVIDED THAT, the allottee of funds
 20 appropriated under section 2(k) shall be the President
 21 of the Federated States of Micronesia. The allottee of
 22 funds appropriated under sections 3 and 4 of this act
 23 shall be the President of the Federated States of
 24 Micronesia or his designee; PROVIDED THAT the allottee
 25 of funds appropriated under subsections 3(a) through

1 3(z) shall be the Governor of Kosrae State or his
2 designee; the allottee of funds appropriated under
3 subsections 3(aa) – 3(all) shall be the Mayor of Lelu
4 Town Government, or his designee EXCEPT THAT the
5 allottee of fund appropriated under subsection 3(au) of
6 this act shall be the Governor of Kosrae or his
7 designee; the allottee of funds appropriated under
8 subsection 4(1)(a) of this act shall be the Governor of
9 Pohnpei State or his designee; the allottee of funds
10 appropriated under subsections 4(1)(l), 4(3)(a),
11 4(3)(f) and 4(3)(i) of this act shall be the Pohnpei
12 Transportation Authority (PTA); the allottee of funds
13 appropriated under subsections 4(2)(a), 4(2)(d),
14 4(2)(e), 4(2)(f), 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j),
15 4(2)(k), 4(2)(l) and 4(2)(m) shall be the Secretary of
16 the Department of Transportation, Communications and
17 Infrastructure or his designee; the allottee of funds
18 appropriated under subsection 4(2)(b) shall be the
19 Pohnpei Utility Corporation (PUC); the allottee of
20 funds appropriated under subsection 4(2)(c) shall be
21 the Office of Fisheries, Pohnpei State; the allottee of
22 funds appropriated under subsection 4(2)(n) shall be
23 the Secretary of the Department of Education or his
24 designee; the allottee of funds appropriated under
25 subsection 4(3)(b) shall be the Pohnpei State Public

1 Safety; the allottee of funds appropriated under
2 subsections 4(3)(c) and 4(3)(e) of this act shall be the
3 Meninkeder of Madolenihmw; allottee of funds
4 appropriated under subsections 4(3)(d) and 4(3)(m)
5 shall be the Luhkenmoanlap of Kittu. The allottee of
6 funds appropriated under subsections 5(1) and 5(6) of
7 this act shall be the Governor of Chuuk State or his
8 designee. The allottee of funds appropriated under
9 subsection 5(2) of this act shall be the Mortlock
10 Islands Development Authority. The allottee of funds
11 appropriated under section 5(3) of this act shall be
12 the Mayor of Weno Municipal Government or his designee.
13 The allottee of funds appropriated under subsection
14 5(4) of this act shall be the Southern Namoneas
15 Development Authority. The allottee of funds
16 appropriated under subsection 5(5) of this act shall be
17 the Faichuk Development Authority. The authority of
18 the allottee to obligate funds appropriated by this act
19 shall lapse on September 30, 2022.”
