BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 2 of Public Law No. 4-91, as amended by 1 Public Law No. 4-111, is hereby further amended to read as follows: 2 "Section 2.
