CONGRESSIONAL BILL NO. 5-222, C.D.1

AN ACT

To further amend Public Law No. 5-15, as amended by Public Law No. 5-28, by further amending section 2 , as amended by Public Law No. 5-28, for the purpose of appropriating the sum of \$20,000\$ from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, as supplemental representation funding for the Congress of the Federated States of Micronesia, and for other purposes.
