AN ACT

To define the functions and responsibilities of the Division of Statistics; to authorize the Division of Statistics to develop an integrated and comprehensive statistical and census information system; to guarantee the confidentiality of data collected; to promote cooperation between the National and State Governments concerning recording and reporting of statistics; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Short title. This act may be cited as the
- 2 Statistics and Census Act of 1988.
- 3 Section 2. Definitions. As used in this act, unless the
- 4 context requires another meaning or unless it is otherwise provided:
- 5 (1) "Census" means a survey of all of the persons, owners,
- 6 officials, agents, corporations, businesses, institutions,
- 7 establishments or other organizations in a field of inquiry;
- 8 (2) "Chief" means the Chief of the Division of Statistics;
- 9 (3) "Congress" means the Congress of the Federated States
- 10 of Micronesia;
- 11 (4) "Division of Statistics" means the Division of
- 12 Statistics within the Office of Planning and Statistics of the
- 13 Federated States of Micronesia;
- 14 (5) "National Government" means the Government of the
- 15 Federated States of Micronesia;
- 16 (6) "National Planner" means the highest management
- 17 official of the Office of Planning and Statistics of the Federated
- 18 States of Micronesia;
- 19 (7) "President" means the President of the Federated
- 20 States of Micronesia;
- 21 (8) "Respondent" includes a corporation, company,
- 22 association, firm, partnership, proprietorship, society, joint stock

- 1 company, individual, or other organization or entity which reported
- 2 or is required to report, or on behalf of which information was
- 3 reported, in response to a questionnaire, inquiry, or other request
- 4 of the Division of Statistics;
- 5 (9) "Sample Survey" means a survey of some but not all of
- 6 the persons, owners, officials, agents, corporations, businesses,
- 7 institutions, establishments or other organizations in a field of
- 8 inquiry; and
- 9 (10) "State government" means the government of any of the
- 10 States of the Federated States of Micronesia.
- 11 Section 3. Statement of purpose. The purpose of this act is as
- 12 follows:
- 13 (1) To define the functions and responsibilities of the
- 14 Division of Statistics;
- 15 (2) To authorize the Division of Statistics to develop an
- 16 integrated and comprehensive statistical and census information
- 17 system;
- 18 (3) To guarantee the confidentiality of data collected by
- 19 the Division of Statistics and other departments and agencies of the
- 20 National Government or jointly by departments or agencies of the
- 21 National and State Governments; and
- 22 (4) To promote cooperation between the National and State
- 23 Governments with respect to the improvement of recording and
- 24 reporting of statistics in the Federated States of Micronesia.
- 25 Section 4. Functions and responsibilities of the Division of

| 1 | Statistics. The Division of Statistics shall have the following |

| 3 | (1) To advise the President and the executive branch on |
| 4 | matters pertaining to statistical policy; |
| 5 | (2) To coordinate the statistical work of all National |

| 9 | (b) The attainment of compatibility between, and the |

| 14 | (d) The formulation and implementation of standards |
| 15 | for carrying out statistical operations; |

| 18 | (f) The recruitment and training of statistical |
| 19 | staff; and |
| 20 | (g) The general promotion and development of |
| 21 | integrated social and economic statistics for the National Government. |
| 22 | (3) To compile, analyze and disseminate official |
| 23 | statistics and related information; |
| 24 | (4) To collect statistics and related information |
| 25 | concerning economic, social, and demographic matters: |

- (5) To prepare and publish an annual statistical abstract 1 for the Federated States of Micronesia; 2 (6) To collect and compile statistical data needed for the 3 formulation of development plans and plan implementation including, 4 but not limited to, the following: 5 6 (a) Data required for the compilation of National 7 accounts; (b) Data on wholesale and retail price changes; 8 9 (c) Data on internal and external trade; and 10 (d) Data on Government and household expenditures. 11 (7) To conduct periodic censuses of population and other 12 censuses and sample surveys at the request of the President; 13 (8) To design and prepare questionnaires for use in 14 censuses or sample surveys; (9) To promote and assist statistical activities in the 15 16 States and to assist State governments and organizations in the 17 collection, analysis and dissemination of statistical information; 18 (10) To undertake periodic surveys of the branches and 19 agencies of the National and State Governments to determine government statistical data requirements and to identify any statistical 20 problems or difficulties being encountered; and 21 22 (11) To liaise with statistical organizations in other

nations and with international organizations regarding statistical

matters.

1 The Division of Statistics shall have the following authority to gather and compile statistical data at such times and for such periods as determined by the National Planner: 3 (1) To gather statistical information; 4 (2) To design and prepare forms and questionnaires; 5 (3) To undertake investigations and carry out censuses and 6 7 sample surveys; 8 (4) To select sampling methodologies for use in surveys; 9 (5) To request respondents to supply estimates where recorded data are not available; 10 11 (6) To prepare programs relating to the acquisition of 12 statistical information; (7) To consult or cooperate with any other person or body 13 for the purpose of compiling statistical data; and 14 15 (8) To undertake any other necessary actions to fulfill its functions and responsibilities. 16 17 Section 6. Conduct of censuses and sample surveys and collection of statistical data. In order to conduct the censuses and sample surveys and collect the statistical data as authorized by 19 20 sections 4 and 5 of this act, the National Planner, the Chief, or other employee of the Division of Statistics designated by the 21 22 National Planner, shall be empowered to: 23 (1) Supply a schedule to any respondent and require such respondent to supply to the best of his knowledge, orally or in 24 25 writing, all of the information requested in the schedule in

- 1 accordance with instructions in the schedule or accompanying it, and
- 2 require that person to complete the schedule, if necessary with the
- 3 assistance of the National Planner or his designee, and to return the
- 4 completed schedule to the National Planner or his designee by a
- 5 specific date; and
- 6 (2) Ask any respondent orally or in writing any questions
- 7 necessary to obtain information for the purpose of compiling
- 8 statistical data or conducting a census or sample survey as
- 9 prescribed under this act, and require the respondent to give, to the
- 10 best of his knowledge, written or oral answers to any such questions.
- 11 Section 7. Dissemination of statistical data; Restrictions on
- 12 use.
- 13 (1) The Chief may furnish copies of tabulations and other
- 14 statistical materials which do not disclose the information reported
- 15 by, or on behalf of, any particular respondent, and may make special
- 16 statistical compilations or surveys, for departments, offices, and
- 17 agencies of the National Government, and State and local governments.
- 18 (2) Information furnished under subsection (1) of this
- 19 section shall not be used by the National Government, or by any of
- 20 its agencies, subdivisions, or public corporations, or by any of
- 21 its officers or employees acting in an official capacity to the
- 22 detriment of any respondent or other person to whom such information
- 23 relates in any legal proceeding, except in the prosecution of
- 24 alleged violations of this act.
- 25 Section 8. Confidentiality of information. The National

| 16 | Section 9. Oath of employees. The National Planner, the |
| 17 | Chief, and every other person employed in carrying out the provisions |
| 18 | of this act shall take and subscribe the following oath: |
| 19 | "I solemnly swear that I will faithfully and honestly |
| 20 | fulfill my duties in accordance with the provisions of the |
| 21 | Statistics and Census Act of 1988, and that I will not |
| 22 | disclose or make known, except as authorized by law, any |
| 23 | information collected in a census or sample survey which |
| 24 | comes to my knowledge by reason of, or through my |
| 25 | employment by, or on behalf of any governmental entity in |

         Section 10. Statistical surveys by other Government departments.
    Departments and agencies of the National Government are authorized to

         Section 11. Exchange of data authorized. The Division of
    Statistics is authorized to enter into any agreement or arrangement

   Governments for the exchange of data collected jointly with that

statistics based upon such data provided that all respondents are

- 1 informed, in writing, that the information is being collected jointly
- 2 on behalf of the Division of Statistics and the other department or
- 3 agency concerned. No such agreement or arrangement shall be
- 4 effective unless it shall require the officers and employees of the
- 5 department or agency of the governmental entity participating in the
- 6 exchange of data to abide by the provisions of this act.
- 7 Section 12. Wrongful disclosure of information prohibited. Any
- 8 person being or having been the National Planner, or Chief, or an
- 9 employee of the Division of Statistics, either temporary or
- 10 permanent, or having taken and subscribed the oath as set forth in
- 11 section 9 of this act, or otherwise having sworn to observe the
- 12 limitations imposed by this act, who publishes or communicates any
- 13 information, the disclosure of which is prohibited under the terms of
- 14 this act, and which comes into his possession by reason of his being
- 15 employed or otherwise providing services under the provisions of this
- 16 act, shall be guilty of an offense, and upon conviction therefor
- 17 shall be fined not more than \$3,000, or imprisoned not more than 3
- 18 years, or both.
- 19 Section 13. Refusal or neglect to answer questions pertaining
- 20 to census data; False answers pertaining to census data.
- 21 (1) Any person being over 18 years of age, who refuses or
- 22 willfully neglects, when requested by any authorized employee of the
- 23 Division of Statistics or other governmental entity, to answer to the
- 24 best of his knowledge any of the questions or any schedule submitted
- 25 to him in connection with any census authorized under this act which

- 1 census data relate to himself or to the family to which he belongs or
- 2 is related, shall be guilty of an offense, and upon conviction
- 3 therefor shall be fined not more than \$100;
- 4 (2) Any person, being over 18 years of age, when requested
- 5 by any authorized employee of the Division of Statistics or other
- 6 governmental entity, to answer to the best of his knowledge any of
- 7 the questions on any schedule submitted to him in connection with any
- 8 census authorized under this act which census data relate to himself
- 9 or to the family to which he belongs or is related, knowingly gives
- 10 any answer that is false, shall be guilty of an offense, and upon
- 11 conviction therefor shall be fined not more than \$500;
- 12 (3) Whoever, being the owner, official, agent, person in
- 13 charge, or assistant to the person in charge, of any corporation,
- 14 business, institution, establishment, or organization of any nature
- 15 whatsoever, refuses or willfully neglects, when requested by the
- 16 National Planner, the Chief, or by any authorized employee of the
- 17 Division of Statistics or other governmental entity to answer
- 18 completely and correctly to the best of his knowledge all questions
- 19 relating to such corporation, business, institution, establishment,
- 20 or other organization, or to records or statistics in his official
- 21 custody, contained in any census authorized by this act, shall be
- 22 guilty of an offense, and upon conviction therefor shall be fined not
- 23 more than \$500;
- 24 (4) Whoever, being the owner, official agent, person in
- 25 charge, or assistant to the person in charge, of any corporation,

- 1 business, institution, establishment, or organization of any nature
- 2 whatsoever, when requested by the National Planner, the Chief, or by
- 3 any authorized employee of the Division of Statistics or other
- 4 governmental entity to answer completely and correctly to the best of
- 5 his knowledge all questions relating to such corporation, business,
- 6 institution, establishment, or other organization, or to records or
- 7 statistics in his official custody, contained in any census
- 8 authorized by this act, knowingly gives a false answer to any such
- 9 question, shall be guilty of an offense, and upon conviction therefor
- 10 shall be fined not more than \$500, or imprisoned not more than 3
- 11 months, or both; and
- 12 (5) Notwithstanding any other provision of this act, no
- 13 person shall be compelled to disclose information relative to his
- 14 religious beliefs or to membership in a religious organization, nor
- 15 shall any person incur any liability under this act for failure to
- 16 disclose information as to his religion.
- 17 Section 14. Administration of Act. The National Planner shall
- 18 be charged with the administration of this act. The National Planner
- 19 shall have all such authority as may be reasonably necessary for the
- 20 performance of any function of the Division of Statistics or for the
- 21 administration of this act, including the authority to promulgate
- 22 such rules and regulations as he deems necessary to conduct periodic
- 23 censuses or sample surveys or to otherwise effect the administration
- 24 of this act. Such rules and regulations shall be promulgated in
- 25 accordance with the provisions of chapter 1 of title 17 of the Code
