FIFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FOURTH REGULAR SESSION, 1988 CONGRESSIONAL BILL No. 5-381, C.D.1, C.D.2,
C.D.3, C.D.4, C.D.5

AN ACT

To amend Public Law No. 5-89 by amending sections 1, 2, 3, 5, 6 and 8
for the purpose of modifying the uses and the apportionment of funds
appropriated for public projects in Truk State, and changing certain
allottees thereof, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 5-89 is hereby amended to
2 read as follows:

3 "Section 1. Statewide public projects. The sum of
4 \$110,216, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States
6 of Micronesia for the fiscal year ending September 30, 1989,
7 for the purpose of funding certain statewide public projects
8 in Truk State. The sum appropriated by this section shall
9 be apportioned as follows:

8 Section 6. Section 8 of Public Law No. 5-89 is hereby amended to
9 read as follows:

"Section 8. Allotment and management of funds and lapse date. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under sections 1 and 3 of this act shall be the Governor of Truk State, except for the funds appropriated by sub-paragraph (1)(d) of section 1 for which the allottee shall be the Truk State Congressional Delegation; by sub-paragraph (2) of section 1 for which the allottee shall be the Executive Director of the Truk Maritime Authority; and by sub-paragraph (3) of section 1 for which the allottee shall be the Executive Director of the Truk Organization of Community Action. The allottee of the funds appropriated under section 2 of this act shall be the Northern Namoneas Development Authority. The allottee of the

1 funds appropriated under sections 4 and 7 of this act, under
2 subsections (5) and (6) of section 5 of this act, and under
3 subsections (4)(a)(i), (4)(b)(i), (4)(c)(i), (4)(d)(i), and
4 sub-paragraph (7) of section 6 of this act shall be the
5 Chairman of the Truk State Congressional Delegation. The
6 allottee of the funds appropriated under sub-paragraphs (1)
7 and (4) of section 5 of this act shall be the Lower Mortlocks
8 Development Authority. The allottee of the funds appro-
9 priated under sub-paragraph (2) of section 5 of this act
10 shall be the Upper Mortlocks Development Authority. The
11 allottee of the funds appropriated under sub-paragraph (3) of
12 section 5 of this act shall be the Mid-Mortlocks Development
13 Authority. The allottee of the funds appropriated under
14 sub-paragraph (1) and subsections (4)(a)(ii), (4)(b)(ii),
15 (4)(c)(ii), (4)(d)(ii), and (4)(e) of section 6 of this act
16 shall be the Hall Islands Development Authority. The
17 allottee of the funds appropriated under sub-paragraphs (2)
18 and (5) of section 6 of this act shall be the Weito Islands
19 Development Authority. The allottee of the funds appro-
20 priated under sub-paragraphs (3) and (6) of section 6 of this
21 act shall be the Pattiw Islands Development Authority. Each
22 allottee shall be responsible for ensuring that these funds,
23 or so much thereof as may be necessary, are used solely for
24 the purposes specified in this act, and that no obligations
25 are incurred in excess of the sum appropriated. The

1 authority of the allottees to obligate funds appropriated by
2 this act shall not lapse until expended."

3 Section 7. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its becoming
5 law without such approval.
