CONGRESSIONAL BILL NO. 5-426

AN ACT

To further amend Public Law No. 5-89, as amended by Public Law No. 5-99, by further amending sections 5 and 6, as amended by Public Law No. 5-99, concerning Truk public projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 5-89, as amended by
2 Public Law No. 5-99, is hereby further amended to read as follows:
3 "Section 5. Mortlocks public projects. The sum of
4 \$350,000, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States
6 of Micronesia for the fiscal year ending September 30, 1989,
7 for the purpose of funding certain public projects in the
8 Mortlock Islands, Truk State. The sum appropriated by
9 this section shall be apportioned as follows:

12	the Federated States of Micronesia for the fiscal year ending	
13	September 30, 1989, for the purpose of funding certain public	
14	projects in the Halls, Western Islands and Namonwitto, Truk	
15	State. The sum appropriated by this section shall be	
16	apportioned as follows:


