CONGRESSIONAL BILL No. 6-225, C.D.1

AN ACT

To further amend Public Law No. 6-10, as amended by Public Laws Nos. 6-43 and 6-46, by further amending section 2, as amended by Public Law No. 6-46, for the purpose of appropriating the sum of \$22,500 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, as supplemental funding for the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 6-10, as amended by
2	Public Law No. 6-46, is hereby further amended to read as follows:
3	"Section 2. Operating expenses of the legislative branch.
4	The sum of \$2,638,373, or so much thereof as may be
5	necessary, is hereby appropriated from the General Fund
6	of the Federated States of Micronesia for the fiscal year
7	ending September 30, 1990, for the operations of the
8	legislative branch of the National Government of the
9	Federated States of Micronesia during fiscal year 1990. As
10	required by Public Law No. 5-119, the Congress of the
11	Federated States of Micronesia hereby declares that the
12	funding appropriated by this section is deemed to be
13	essential. The sum appropriated by this section shall be
14	apportioned as follows:
15	(1) Office of the Speaker and Members
16	(a) Personnel expenses \$ 400,100
17	(b) Travel
18	(c) Contractual services,
19	grants, subsidies, and contributions 144,300
20	(d) Others 50,000
21	(2) Staff Offices
22	(a) Personnel expenses 718,635
