This Act may be cited as the Supplementary Appropriation (No.1) Act 1. 2010.

Authorisation of issue of \$80,357.00 from the Consolidated Fund

The issue from the Consolidated Fund is hereby authorized of a sum of \$80,357.00 to be applied for recurrent expenditure to the service of the 2. year ending 31 December 2010.

Appropriation

The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the schedule annexed 3. to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.

EXPLANATORY MEMORANDUM

- 4. The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of section 109(3) of the Constitution.
