**AN ACT TO AUTHORISE SUPPLEMENTARY APPROPRIATION OF  
MONIES OUT OF THE CONSOLIDATED FUND FOR RECURRENT  
EXPENDITURE FOR THE SERVICE OF THE YEARS ENDING 31  
DECEMBER 2012 AND 2013**

**Short title**

1. This Act may be cited as the Supplementary Appropriation (No. 1) Act 2013.

**Authorisation of issue of \$2,044,555 from the Consolidated Fund**

2. The issue from the Consolidated Fund is hereby authorized of a sum of \$2,044,555 to be applied for recurrent expenditure to the service of the years ending 31 December 2012 and 2013.

**Appropriation**

3. The sum specified in section 2 shall be appropriated for the supply of the Head(s) of Expenditure specified in Column 1 of the schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.

### EXPLANATORY MEMORANDUM

4. The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of section 109(3) of the Constitution.


