1. This Act may be cited as the Supplementary Appropriation (No. 1) Act 2014.

### Authorisation of issue of \$555,032 from the Consolidated Fund

2. The issue from the Consolidated Fund is hereby authorized of a sum of \$555,032 to be applied for recurrent expenditure to the service up to the year ending 31 December 2014.

## **Appropriation**

3. The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.
