**AN ACT TO AUTHORISE SUPPLEMENTARY APPROPRIATION OF MONIES
OUT OF THE CONSOLIDATED FUND FOR RECURRENT EXPENDITURE FOR
THE SERVICE OF THE YEAR ENDING 31 DECEMBER 2015**

Commencement:

MADE by the Mancaba ni Maungatabu and assented to by the Beretitenti.

Short title:

1. This Act may be cited as the Supplementary Appropriation (No. 1) Act 2015.

Authorisation of issue of \$7,903,377 from the Consolidated Fund

2. The issue from the Consolidated Fund is hereby authorized of a sum of \$7,903,377 to be applied for recurrent expenditure to the service of the year ending 31 December 2015.

Appropriation

3. The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the Schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.


EXPLANATORY MEMORANDUM
