

AN ACT TO AUTHORISE SUPPLEMENTARY APPROPRIATION OF MONIES  
OUT OF THE CONSOLIDATED FUND FOR RECURRENT EXPENDITURE FOR  
THE SERVICE OF THE YEAR ENDING 31 DECEMBER 2017 AND 31 DECEMBER  
2018 (NUMBER 1)

MADE by the Maneaba ni Maungatabu and assented to by the Beretitenti.

**Short title:**

1. This Act may be cited as the Supplementary Appropriation (No.1) Act 2018.

**Authorisation of issue from the Consolidated Fund**

2. The issue from the Consolidated Fund is hereby authorized of a sum of \$2,429,526 that had been applied for recurrent expenditure to the service of the year ending 31 December 2017.
3. The issue from the Consolidated Fund is hereby authorized of a sum of \$400,000 to be applied for recurrent expenditure to the service of the year ending 31 December 2018.

**Appropriation**

4. The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of Schedule 1 annexed to this Act in the sums respectively specified in relation thereto in Column 2 of Schedule 1.
5. The sum specified in section 3 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of Schedule 2 annexed to this Act in the sums respectively specified in relation thereto in Column 2 of Schedule 2.

EXPLANATORY MEMORANDUM


- This Act charges upon the Consolidated Fund a sum which is required for recurrent expenditure for the years ending December 2017 and December 2018.


