SUPPLEMENTARY APPROPRIATION (NO. 2) ACT, 1979.

EXPLANATORY MEMORANDUM.

- 1. This Bill charges upon the Consolidated Fund a sum which is required for recurrent expenditure for the year ending on December 31, 1979, in addition to the amount appropriated for that year by the Appropriation Ordinance, 1978.
- 2. The sum required is to provide for monies expended in excess of sums already appropriated, and for monies expended for which no monies have yet been appropriated.
- 3. The Bill provides that the additional amounts charged shall be divided between and expended upon the services listed in the Schedule to the Bill.
- 4. The Bill is presented to the Maneaba in accordance with the requirements of Section 109(3) of the Constitution.
