1. This Act may be cited as the Supplementary Appropriation (No. 2) Act 1988.

2. The issue from the Consolidated Fund is hereby authorised of a sum of \$565,487 to be applied for recurrent expenditure to the service of the year ending 31st December 1988.







SUPPLEMENTARY APPROPRIATION (NO 2) ACT 1988

EXPLANATORY MEMORANDUM

1. This Act charges upon the Consolidated Fund a sum, which is required for recurrent expenditure for the year ending 31 December 1988, in addition to the amount appropriated for that year by the Appropriation Act 1987 and the Supplementary Appropriation (No 1) Act 1988.
2. The sum required is to provide for money expended in excess of sums already appropriated.
3. The Act provides that the additional amount charged shall be expended upon the service listed in the Schedule to the Act.
4. The Act was presented to the Maneaba ni Maungatabu in accordance with the requirements of Section 109(3) of the Constitution.
