Short title.

1. This Act may be cited as the Supplementary Appropriation
(No. 3) Act, 1980.

Authorisation
of issue of
\$1,059,903 from
the Consolidated
Fund.

2. The issue from the Consolidated Fund is hereby authorised
of a sum of \$1,059,903 to be applied for recurrent expenditure
to the service of the year ending 31 December, 1980.

Appropriation.

3. The sum specified in section 2 shall be appropriated for
the supply of the Heads of Expenditure specified in Column 1
of the Schedule annexed to this Act in the sums respectively
specified in relation thereto in Column 2 of the Schedule.



SUPPLEMENTARY APPROPRIATION (NO. 3) ACT, 1980

EXPLANATORY MEMORANDUM

1. This Act charges upon the Consolidated Fund a sum, which is required for recurrent expenditure for the year ending 31 December, 1980, in addition to the amounts appropriated for that year by the Appropriation Act, 1979, and the Supplementary Appropriation Acts, 1980 (Nos. 2 & 8 of 1980).
2. The sum required is to provide for monies expended in excess of sums already appropriated.

3. The Act provides that the additional amount charged shall be divided between and expended upon the services listed in the Schedule to the Bill.
4. The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of section 109(3) of the Constitution.
