Section 36(1)

DELEGATION OF POWERS TO TE KAUOMAN NI BERETITENTI AND MINISTER OF COMMERCE, INDUSTRY & COOPERATIVES CERTAIN FUNCTIONS OF TE BERETITENTI WHILST ABSENT FROM 22 JANUARY TO 10 FEBRUARY 2009

In exercise of the powers conferred upon me by section 36(1) of the Constitution, I hereby direct and authorize, during my absence from Tarawa to attend the Special Forum Leader's Meeting in Port Moresby and the Delhi Sustainable Development Summit in New Delhi from **22 January to 10 February 2009**, the Honourable Teima Onorio, Te Kauoman ni Beretitenti and Minister of Commerce, Industry & Cooperatives to discharge the following functions of the Office of the Beretitenti over the said period.

- (a) The functions under section 48 of the Constitution (relating to proceedings in Cabinet);
- (b) The functions under section 92 of the Constitution (relating to oath of office);
- (c) The functions under section 99 of the Constitution (relating to the appointment, removal and exercise of disciplinary control of public employees);
- (d) The functions under the Public Order Ordinance; and
- (e) The functions under the Proceedings By and Against the Republic Ordinance
