PRICES ORDINANCE (CAP 75)

Section 3(1) and 5)

PRICES (AMENDMENT) ORDER (NO.1) OF 2009

In exercise of the powers conferred upon me by section 3(1) and 5 of the Prices Ordinance (Cap 75), I hereby make the following Order:-

Citation

1. This Order may be cited as the Prices (Amendment) Order (No.1) of 2009

Commencement

2. This Order shall be deemed to come into operation on the 9th March 2009.

Amends Parts I and II of Prices (Regulation) Order (No.1) of 2009

3. Parts I and II of the Schedule to the Prices (Regulation) Order (No.1) of 2009 is hereby amended by deleting the wholesale and retail prices referring to Rice, Sugar, Flour, Benzene and Kerosene reflected in the table below and the following new prices substituted-
